Follow these steps:

# STEP 1

### **Consult a Qualified Forester**

**Professional foresters** provide technical assistance to private woodlot owners to assess the state of their forest and to propose sustainable forest management strategies. Woodlot advisors work in private practices, others for group venture organizations. # Planning Beneficial WOODLOT MANAGEMENT Practices

# **STEP 2** Enhance Your Woodlot by Planning its Development

Planning takes the form of a forest management plan. The information contained in this plan will provide you with knowledge of your woodlot to optimize its potential. The management plan will allow you to make sustainable development decisions according to your interests and your objectives.

# >> FOREST MANAGEMENT PLAN CONTENT:

- The owner's objectives
- A property scale map, to identify:
  - Forest stand typing
  - Environmentally sensitive sites
- Silviculture suggestions according to your woodlot potential and your objectives.

# **STEP 3** Register for Forest Producer Status

Once the forest management plan is completed, you can register to obtain the recognized forest producer status delivered by the Quebec government. The status will give you access to tax incentives and financial assistance programs to carry out forestry activities (refer to our "Forest Management Support Programs" section). The professionnal forester who designs your forest management plan can guide you through this registration process. # >>> REQUIREMENTS TO BECOME A RECOGNIZED FOREST PRODUCER

- A valid forest management plan by a professional forester
- Own at least 4 hectares (9,9 acres) of property devoted to forest activities.
- Register for forest producer status and obtain a forest producer certificate (**www.mffp.gouv.qc.ca**) which indicates lots registered.

# PROMOTING TREE PLANTING AND BEST SILVICULTURE PRACTICES

### Afforestation / Reforestation

L'Agence des Forêts Privées de l'Outaouais plants hundreds of thousands of trees annually in order to regenerate woodlots after windthrows, and recuperation of diseased and insect infested tree stands. Seedlings are supplied by the government of Quebec and subsidies are available to do site preparation, planting and maintenance until free to grow. In step with climate change, our region has an ambitious reforestation plan of fallow land and abandoned farmland in order to sequester carbon. These programs are funded by a Federal-Provincial agreement, Tree Canada Foundation and the Quebec gouvernment.

### Harvesting mature and diseased trees, and other forest tending methods will allow for:

- Continuous improvement of the quality and health of your woodlot thus increasing its value
- Attainment of **sustainability** and **productivity** of your woodlot
- Proper spacing and light enhancement to promote the growth of young trees
- Tending and rejuvenation of your woodlot to increase its Carbon Sequestration capacity

The forest is a natural resource which must be protected and optimized through proper tending. In addition to providing majestic landscapes, it provides habitat for wildlife and plants. It creates wealth and contributes to the regional economy, generating revenue for woodlot owners, but also for forestry workers, entrepreneurs, truckers, wood-processing plants workers, furniture manufacturers, distributors and retailers, all this through the use of a renewable material.

Furthermore, an increased use of wood when building in Quebec is a significant contribution towards the fight against greenhouse effects. Wood is a renewable resource sustainably managed and, at its end-of-life cycle, it could be re-used for new buildings or recycled into by-products (wood fibreboard, mulch or bioenergy production).

# FOREST MANAGEMENT SUPPORT PROGRAMS

# >> MANAGED WOODLOT DIRECT ASSISTANCE PROGRAM

Managed by the regional forest agencies, this direct financial assistance program offers incentives to protect and enhance woodlots operated under benefical practices. Financial assistance is offered to licenced forestry advisors and status recognized woodlot owners for conducting forest operations on private land. To obtain financial support, the forest producer must use the services of a professional forester or licensed forestry adviser.

#### **Activities financed:**

- Tree planting
- Technical assistance for silvicultural activities
- Silviculture operations and harvesting

## >>> PROPERTY TAX REFUND PROGRAM

It is a refundable tax credit for status registered forest owners who invest into specified /eligible silviculture operations and roadwork, which work has been attested by the report of a professional forester and whose value is equal or superior to the amount of the property tax (municipal tax). This program allows to recover up to **85% of the municipal and school taxes** paid for the woodlot.

## >> « FAUNA-FOREST » WILDLIFE ENHANCEMENT PROGRAM

Managed by the "Fondation de la faune du Québec", this program provides information, technical support and financial assistance to private woodlot owners on wildlife resource management, conservation and natural reserve options of your woodlot property. To benefit from this program, the owner must retain the services of an eligible organization.

### **Examples of subsidized activities:**

- Incorporating a wildlife component to the forest development plan
- Providing winter habitats for the deer in eligible areas
- Voluntary preservation of wetlands or other sensitive natural habitats
- Dedication of natural reserves
- Improvement or restoration of wildlife habitat

# >> FOREST CREDIT PROGRAM

This program jointly developed with the **Minister of Forests, Wildlife and Parks** and administered by "*La Financière Agricole du Québec*" (Quebec Farm Credit Corporation) aims to provide financial support to forest owners when woodlots are acquired to consolidate a working woodlot larger than 60 hectares. A woodlot management plan, and woodlot owner status are conditions to eligibility.

### **Examples of financed activities:**

- Guidance in the elaboration of a business plan and financial analysis of your project
- Purchase plan for private woodlot / forestry companies
- Machinery / forest equipment acquisition
- Maple production equipment
- Buildings construction / renovation
- · Silvicultural and roadwork activities.

# **)) OTHER TAX PROGRAMS**

The **Woodlot Income Averaging Measure** offers the possibility to apply income averaging to a portion of harvest net income from certified forestry commercial activities over a period not to exceed seven years.

The **Forest Operations Tax Exemption** is a Provincial and Federal (10%) tax exemption on net income resulting from harvest operations for net wood sales up to \$65,000.

The **Fuel Tax Refund** provides a refund for tax paid on gasoline or fuel oil used to operate motor vehicles used for farming or forest operations when the machinery is registered for use exclusively on private roads.
